(PS.2) Department, dt.01.01.1994, as amended from time to time.

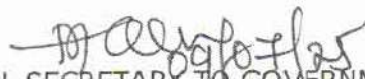

The Government have also prescribed the books to be introduced for Classes I and VI which have to be followed for the Compulsory Teaching & Learning of Telugu language as per this Act 10 of 2018 & the connected Rules and also follow the guidelines issued in G.O.Ms.No.36, School Education(General) Department, dt. 16.12.2017 for the safety and security of the children in the schools.

3. The School Management shall be having full responsibility if any court case arise in this regard. The details furnished if any by the management is found to be false or incorrect at any stage, this No Objection Certificate is liable to be cancelled.
